The top cover of the Layla mattress is removable and is washable. It is color-coded to make it easy to identify. The soft side is at the top of the mattress and the hard side is below. The cover is made of 66% polyester and 30% viscose. It also contains 44% poly/lycra. The ThermoGel cooling component of the cover reacts to body temperature and can be cleaned.

Layla mattresses are available with a trial period of 120 nights that lets you test it for up to four months. If you're not completely satisfied you can return it for a full refund within two weeks. The lifetime warranty is also provided by the company which is greater than the industry average. The warranty covers excessive sinkage as well as rips in seams as well as manufacturing flaws.

Layla mattresses provide excellent support for the spine and neck. They also offer pressure relief and comfort for stomach-sleepers. The firm side of the Layla provides firm support, while the soft side offers medium support. In addition the Copper infusion inside the cover can help maintain your body temperature evenly. Copper is also excellent at dispersing heat, so you won't be prone to hot spots or overheating.

This hybrid mattress offers excellent motion isolation, with a 9-out-of-10 edge support rating. You may experience some small movements when your partner changes positions or a pet moves out of the room. The Layla also provides a solid perimeter. The mattress's base provides solid edge support for the side that is soft. This side is a good option for sleepers who are heavier.
